At Radlett Lodge School we aim, within a safe environment, to provide students with the skills, knowledge and understanding to develop online safety skills that will keep themselves safe online within the school and beyond, now and in the future.

# This includes learning about:

- Protecting their identity and personal information.
- Respecting others online.
- Maintaining privacy settings.
- How to report concerns.
- Never arranging to meet with people they meet online.



The Prevent Duty is the duty in the Counter-Terrorism and Security Act 2015 on specified authorities, in the exercise of their functions, to have due regard to the need to prevent people from being drawn into terrorism.

All staff at Radlett Lodge School have received PREVENT training and understand our duty to report possible radicalisation.

If you have any concerns related to possible radicalisation please contact a member of our safeguarding team who will follow procedures, which will include reporting to Channel—blue form recording.

### **How to Report Concerns**

At Radlett Lodge School we have a system for reporting and recording concerns relating to suspected emotional, physical, sexual or mental abuse.

We take all concerns seriously and maintain the attitude of "It could happen here".

Permanent staff record concerns using CPOMS.

Agency and visitors should record concerns using the yellow forms located in the main school office or Lodge Team Leaders office.

Please discuss any concerns with one of our Designated Safeguarding Leads who will be able to advise and support you to complete the forms. As safeguarding is an emotive subject they will also support you should you be emotionally impacted by the concerns raised.

All staff receive regular safeguarding updates and training. All of our policies and procedures are in accordance with 'Keeping Children Safe in Education' (2019) and 'Working Together to Safeguard Children' (2018).
